Dear Sir,

With reference to your application dated 07.09.2022 and subsequent interview held on 18.10.2022, the Competent Authority, National Council of Science Museums Kolkata, (herein after called NCSM), is pleased to engage you as a Consultant (Science Museum Project) for a period of 01 year at a consolidated monthly emolument of ₹1,16,300/- [Rupees one lakh sixteen thousand three hundred] only with the following terms & conditions:

- a) Your engagement is purely on contract basis and you are initially posted at National Science Centre, Delhi. However, you may be transferred or/and posted at any work site or centre or museums for execution/supervision of works;
- b) You will not be entitled to any other allowance/fee apart from the above consolidated monthly remuneration of ₹1,16,300/- [Rupees one lakh sixteen thousand three hundred] only (Remuneration ₹1,09,100/-+ Admissible Transport Allowance ₹7,200/-);
- c) During the period, you are required to render consultancy service to various upcoming projects of NCSM viz., Kedarnath, Energy Park with NTPC, Science City Dehradun under SPoCS and such other projects(s) to be assigned by NCSM from time to time.
- d) The Income Tax or any other tax as applicable will be deducted at source from the fee payable as per Government Guidelines/Instructions from your emolument;
- e) You will not be eligible for any other facility or/and benefit applicable for the regular employees of NCSM;
- f) During the period of one year, the contract is liable to be terminated with 15 days' notice from either side without assigning any reason.

- g) You can be disengaged at any point of time for breach of any condition of non-disclosure undertaking and can be proceeded against relevant law in force without any notice or/and without assigning any reason thereof;
- h) You shall attend office according to the working hours of National Science Centre, Delhi or work site/ museum/centre where you are posted/attached or/and as per the requirement of NCSM;
- i) Paid leave of absence is allowed at the rate of 1.5 days for each completed month of engagement. Accumulation of leave beyond a calendar year shall not be allowed. Encashment of leave is also not allowed;
- You will be entitled for TA/DA as applicable to your last Pay Level during your contractual engagement;
- k) Your engagement is extendable beyond 1 year at the sole discretion of NCSM subject to your work deliverance during the contractual period and requirement of the Council;
- You are required to submit a non-disclosure undertaking as per the attached format;

If the terms and conditions as mentioned above are acceptable, you may communicate your acceptance to this office within 07 (seven) days from issue of this letter and join duty on 01.12.2022.
