**General Information and Instructions**

1. The instruction given herein will be strictly binding on the tenderers and deviation, if any will make the tender or tenders liable to be considered invalid. Tenders incorporating additional conditions by the tenderer are liable for rejection.
  2. Bids shall be submitted online only at CPPP website: <https://eprocure.gov.in/eprocure/app> Manual bids shall not be accepted.
  3. The instruction given in “**Annexure-A**” for “**Instruction for Online Bid Submission**” should be strictly followed during submission of the Bid.
  4. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
  5. **Validity of Bids:** The Bids should remain valid for 90 days from the date of Financial Bid opening.
  6. **Rejection of Bids:** Canvassing by the Bidder in any form, unsolicited letter and post-tender correction may invoke summary rejection. Conditional tenders will be rejected. Non-compliance of applicable General Information and Instruction will disqualify the Bid.
  7. The tenderers should have Digital Signature Certificate (DSC) for filling up the Bids. The person signing the tender documents should be authorized for submitting the on line e-tender.
  8. The tenderers shall fill up the Prescribed Format for submission of **Technical (Techno-commercial) Bid as per “Annexure-D”** format duly signed by the authorized signatory. The person signing the tender document should be authorised for submitting the online e-tender.
  9. The Financial Bid shall be filled in and signed by the authorized signatory online as per Proforma “**Annexure-“E”**” available at Central Public Procurement Portal e-tender system website <http://eprocure.gov.in/eprocure/app>. Off line Financial Bid shall not be accepted.
- 10. Tender must be uploaded online by the bidder in two separate covers marked Cover-I and Cover-II. The contents of Cover - I and Cover-II will be as follows:**

**Cover – I**

- i) The scanned copy of the Demand Draft/Pay Order for Rs. 28,000.00 (Rupees twenty-eight thousand only) as Earnest Money Deposit. In case of online transfer of money, the UTR No. of the transaction shall be prepared in the letter head of the bidder and uploaded.

In case the bidder fails to submit any of the documents as stated above, the other part of their tender i.e. 'Cover- II' shall not be considered for further download and shall be rejected straightway without any further reference. The Technical Bids and other documents i.e. 'Cover- I' will be downloaded and evaluated at the first stage to select the techno-commercially capable and competent bidders. At the second stage, Financial/Price Bids i.e. 'Cover - II' of only the techno-commercially acceptable offers will be downloaded and evaluated for further ranking before awarding the contract. After opening of 'Cover -I', if all the bids are found techno-commercially unacceptable, the Financial (Price Bid) Bids i.e. 'Cover - II' submitted by the bidders against this Tender shall not be opened/downloaded for obvious reasons.

**Instructions for Online Bid Submission**

1. The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.
2. More information useful for submitting online bids on the CPP Portal may be obtained at <https://eprocure.gov.in/eprocure/app>

**REGISTRATION**

- 1) Bidders are required to enrol on the e-Procurement module of the Central Public Procurement Portal (URL: <https://eprocure.gov.in/eprocure/app> ) by clicking on the link “**Online bidder Enrolment**” on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC’s to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

**SEARCHING FOR TENDER DOCUMENTS**

- 1) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective ‘My Tenders’ folder. This would enable the CPP Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.
- 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

**PREPARATION OF BIDS**

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use “My Space” or “Other Important Documents” area available to them to upload such documents. These documents may be directly submitted from the “My Space” area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

### **SUBMISSION OF BIDS**

- 1) Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 3) A standard Price Schedule format (BOQ) has been provided with the tender document to be filled by all the bidders. Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BOQ file, open it and complete the white coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. **In case no rate value is required to be quoted in any particular cell, that cell must be kept blank, figure ‘0’ (zero) shall not be entered in such cell(s).** Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.
- 4) Bidder has to select the payment option as “offline” to pay the tender fee/EMD as applicable and enter detail of the instrument.
- 5) Bidder should submit the EMD as per the instructions specified in the tender document. The original D.D./ Pay Order should be posted/couriered/given in person to the Tender Processing Section, latest by the technical bid opening date & time. The detail of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected. Bidders can also deposit their EMD through online mode as per the details mentioned above.
- 6) The server time (which is displayed on the bidders’ dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- 7) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by

unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid openers public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.

- 8) The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 9) Upon the successful and timely submission of bids (i.e. after Clicking “Freeze Bid Submission” in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- 10) The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.

**GENERAL TERMS & CONDITIONS (GTC) FOR SUBMISSION OF TENDER FOR SUPPLY, INSTALLATION, TESTING & COMMISSIONING OF LASER WELDING MACHINE (FIBER LASER) WITH ACCESSORIES AND FEEDING WIRES STRICTLY AS PER ENCLOSED TECHNICAL SPECIFICATIONS.**

01. Bidders should have necessary infrastructure and facilities so as to take up the job of the tendered item strictly as per enclosed specifications and also have infrastructure for providing warranty and after sales service with required financial capability.
02. **Price:** The prices and rates indicated/quoted shall be inclusive of cost of materials, loading, transportation, unloading and delivery **at National Council of Science Museums, Kolkata along with installation, testing & commissioning** and providing warranty as mentioned in the specifications. The rate of GST to be imposed on the rates shall be clearly mentioned. Prices and rate quoted shall be firm and fixed for the entire period of execution of the order and no escalation of rate on any ground whatsoever shall be applicable.
03. The successful bidder shall submit the following within the seven days of placement of order:-
  1. Duplicate copy of the order duly signed and stamped as a token of acceptance of the order.
  2. Security Deposit @05% of the ordered value by way of Demand Draft/ Pay Order/online transfer.
04. Time is the essence of the tender. The entire work of Supply of the tendered items as per enclosed specifications, shall be completed at NCSM **within 30 (thirty days) from the date of placement of the order.** For non-compliance of any of the terms covered under the order and or non-delivery of the tendered items, complete in all respects within the above stipulated delivery period, the Council shall have the right either to cancel the order or impose penalty as detailed in clause 09 and the decision in this regard taken by the Council shall be final and binding on the successful bidder.
05. The EMD submitted by the unsuccessful bidders will be returned within one month from the date of opening of the financial bid or finalisation of the tender whichever is later. **The EMD of the successful bidder will be returned on receipt of security deposit to the council as per clause 17 of GTC.** No interest will be paid for the EMD retained with the council.

**06. Inspection Clause, Acceptance Criteria and Proving of the machine: -**

**Stage –I**

The successful tenderer shall mandatorily arrange for Inspection of the equipment including its accessories as per given specifications at the manufacturing site within 20 days from the date of placing the order.

**Stage-II**



Final inspection of the equipment shall be conducted at National Council of Science Museums upon successful installation of the machine.

The above two inspections will be made by the authorised officials of National Council of Science Museums. Any defect pointed out by the competent representative of National Council of Science Museums during such inspection has to be promptly rectified at the cost, including material cost of the successful tenderer(s) to meet the desired quality, and specification as per requirement of National Council of Science Museums failing which action shall be taken as deemed fit by the National Council of Science Museums. The decision of National Council of Science Museums in this regard shall be final and binding on the successful tenderer(s).

**07.** The successful tenderer shall arrange training in operation, programming and maintenance of the machine to 3 Technical staff members of the Council for at least 3 consecutive days or till the operation of the machine at workshop during PDI and the same training shall be arranged at the installation site (i.e. National Council of Science Museums, Kolkata) also.

**08. Defect Liability Period**

The Defect Liability Period shall be **THREE YEARS** from the date of certification of the completion of satisfactory installation and commissioning of the machine. The successful bidder shall be responsible for all defects of the installed machine, manufacturing or other defects of components, spare parts etc. for a period of three years from the date of satisfactory completion of the installation and commissioning of the machine. The successful bidder, shall at their own cost, rectify the defects and or replace the defective parts/equipment, up to the complete satisfaction of the competent authority of the National Council of Science Museums within reasonable time. If they fail to rectify the defects as mentioned above, the same shall be done departmentally or otherwise and the cost thereof will be deducted from the EMD/ security deposit of the successful bidder.

**09. Penalty Clause:-**

The time allowed for executing the supply as detailed in Clause No.04 shall be strictly observed by the successful bidder. The supply shall throughout the stipulated period of the order, be proceeded with all the diligence (time being deemed to be the essence of the order) and the successful bidder shall pay to the Council, an amount equal to 1% of the amount of the contract value for every week that the supply may remain incomplete as per delivery schedule as stipulated in Clause No.04 subject to a maximum compensation of 10% of the contract value after which period, action will be taken by the Council as will deem fit. If the successful bidder fails to pay the amount as above, action will be taken against the bidder as deemed fit by the Council including forfeiting of EMD/ Security deposit.

**The Council may extend the time of delivery of the ordered items at their discretion on the application of the successful bidder for such purpose provided that the Council considers the reasons for such extension as good, sufficient and acceptable.**

**10.** Every effort should be made to complete the supply by the successful bidder within the specified time schedule. In case the firm fails to comply with Clause No.04 within the specified time schedule as per the finalized and accepted terms & conditions, the Council shall have the right to either impose penalty clause or cancel the order forthwith and take appropriate action as deemed fit by the Council. The decision of the Council in this regard shall be final and binding on the successful bidder.

**11. Payment terms:-**

No advance payment shall be made by the Council under any circumstances. Digital Payment (e-Payment) through RTGS/NEFT/TT/etc. shall be released within 30(thirty) working days from the date of receipt of Invoice/Bill (supplies covered under of clause No.04), duly supported by

received challan subject to satisfactory inspection report of the ordered work issued by the competent authority of the Council. **Invoice should be submitted indicating the GST Registration number, Name of the Banker, IFSC Code, Account number, RTGS and Swift number of the banker etc. for releasing e-payment to the supplier.**

**Statutory Deductions:** Tax Deduction at Source (TDS) shall be affected, as and when applicable, as per Govt. of India Rule.

- 12. Warranty: The warranty shall be 03 years onsite (01-year standard + 02 years extended) on entire machine components including laser source as stipulated in the technical specification provided by the successful bidder and the warranty certificate shall be submitted along with the Invoice failing which payment will not be made.** The bidder shall be responsible for all defects of materials including defective workmanship, use of defective materials etc. for the entire warranty period effective from the date of final acceptance of the ordered materials.
- 13.** If it is noticed that the goods supplied do not conform to the specification of the order, the Council shall have the right to reject the materials in part or full. The supplier shall be liable to replace the rejected materials within the stipulated time. Till the replacement is done, the rejected materials shall be lying at the risk, cost and responsibility of the supplier. If the supplier does not arrange to replace the rejected materials within the stipulated time, the same may be disposed of at the risk of the supplier and in the manner which the Council will deem fit. The Council shall be entitled to retain the proceeds of the disposal either in part or in full towards expenses incurred on storage, handling and disposal of the materials. The Council shall also be entitled to recover the expenses made by them on account of storage & handling of such rejected goods till the goods are removed from the premises of the Council. In case the successful bidder fails to pay the damages to the Council, appropriate action will be taken against them as deem fit by the Council.
- 14.** The authorities of the National Council of Science Museums reserves the right to amend, alter or modify the terms & condition mentioned above if necessary from time to time.
- 15.** The authorities of National Council of Science Museums, who does not bind themselves to accept the lowest tender, reserves the right to reject or accept any or all tenders wholly or partially without assigning and reason whatsoever or split the order.
- 16.** The quantities specified in the tender may be decreased or increased at the sole discretion of NCSM authorities.
- 17.** The Successful tenderer shall deposit 05 % of the total ordered value at NCSM as refundable security deposit and the such Security Deposit will be retained with NCSM till the defect liability period and shall be refunded after successful completion of Defect Liability Period of 03 years as stipulated in clause 08 of GTC.
- 18.** All disputes and differences between the successful bidder and the Council of any kind except quality of workmanship and materials whatever arising out of or in connection with the order on carrying out the supply (whether during the progress of the work or after their completion and whether before or after the determination, abandonment or breach of the Terms & conditions of the order) shall be referred to the sole arbitration of a person nominated by the Director General, National Council of Science Museums, whose decision in this regard will be final and binding on both the successful bidder and the Council.

The provisions of the Arbitration and Reconciliation Act 1996 or any statutory modification or re-enactment thereof and of the rules made there under for the time being in force shall apply to arbitration's proceedings under this Clause.
